Executive Session** - MGL c 30A, §21, (2) & (3): (2) To conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel; (3) To discuss strategy with respect to collective bargaining or litigation if an open meeting may have a detrimental effect on the bargaining or litigating position of the public body and the chair so declares.

RW moved to enter Executive Session. GJ 2nd. Roll call: Yes – KC, SE, SH, GJ, AP, JW, RW. Motion passed unanimously. Moved to executive session at 8:24.

### A. Incentive Pay for Food Service Staff

Food Service Director Eliza Calkins has requested summer program workers be paid time-and-a-half.

AP moved that summer meals staff receive time-and-a-half pay going forward and retroactively for the Summer 2020 Meals Program, with a cap of \$7/hour on the half-time rate. SE 2nd.

#### Discussion:

- \$7 cap recommended by Calkins ensures \$ amount can be adequately covered by federal reimbursements. No extra cost to GPS.
- All summer meals are free, so income is affected.
- All students at Newton, Federal Street get free meals; not Four Corners. Unclear whether GMS/GHS also eligible for free meals. SE to confirm.
- Supt. reported 115.000 meals served since school closed.
- Many families count on these meals; important service.

#### Roll call: Yes - KC, SE, SH, GJ, AP, JW, RW. Motion passed unanimously.

Suggestion to ask community for donations of equipment, supplies that schools need. Will discuss with Supt.

#### **B. Superintendent Contract**

General discussion of timeline and contract process.

JW moved to leave executive session. SH 2nd. Roll call: Yes – KC, SE, SH, GJ, AP, JW. RW. Motion passed unanimously. Returned to public session at 9:04 p.m.
